NBPME is Changing its Licensing Exam Names



The National Board of Podiatric Medical Examiners is changing the name—but not the design—of its licensing examination series. The tests remain unchanged in every aspect of content, competencies measured, and scoring methodology. However, what had been known as NBPME Parts I, II, and III will now be designated as the American Podiatric Medical Licensing Examination (APMLE) Parts I, II, and III. The NBPME remains as the parent organization that owns and is responsible for production and scoring of each test in the series.

Clinical Skills Examination (CSEC)

A committee from NBPME has met several times with representatives from the Clinical Skill Examination Committee (CSEC) from NBME/ECFMG at the National Board of Medical Examiners offices in Philadelphia to discuss a CSE for Podiatric Medicine. The Clinical Skills Examinations would be in addition to NBPME's current Part II examination of clinical knowledge and would be intended to provide a better measure of a candidate's ability to interact with patients, apply appropriate history and physical skills, and develop plans of action which are documented in the medical record.

Drs. Ann Jobe, M.D. and Allyson Lehman, D.P.M. presented a proposal to our Board at the annual meeting August 14th. That proposal outlined the steps and the costs beginning with a feasibility study and leading to the development and administration of a pilot examination. NBPME accepted the overall philosophy of the developmental stages and will work with CSEC to complete the feasibility study as the first step.

Biometrics

For a smooth and secure check-in process, NBPME now uses biometric-enabled check-in at all Prometric test centers. The test center administrator will validate a government-issued photo ID by using a special scanning device to compare the electronic information encoded on the ID to the information printed on the front of the card. Optical character recognition software quickly gathers information from the ID card or passport, captures an image of the ID, and extracts the picture. Next, a fingertip will be scanned, creating a secure record of the person holding the ID. Finally, the test center administrator captures a test-day photo image to document the event. If conflicting information is uncovered at any stage of the biometric-enabled check-in process, the test center administrator will file a report and notify Prometric.

National Boards Forum

The NBPME participated with the two organizations that prepare examinations for allopathic and osteopathic physicians in a meeting with representatives from the schools and colleges of podiatric medicine. The purpose of the August meeting was to present the test development and scoring processes used by each. A formal report is being prepared by the APMA and will be posted by APMA upon completion. The NBPME provided a complete, detailed description of how each examination is designed and developed to ensure that each part of the series measures what it is intended to measure, and does so consistently. Other actions agreed upon at the forum include modifications to enhance the involvement of school faculty in their role in test preparation.
